

國立臺灣師範大學延長徵求第 15 任校長候選人徵求啟事

- 一、公開徵求本校校長候選人，任期自115年2月22日起至119年2月21日止，歡迎符合資格者參與遴選。校長任期為4年，依相關規定得續聘一次。
- 二、依《教育人員任用條例》第33條及《本校校長遴選組織及運作辦法》第11條規定，本校校長候選人之資格及條件如下：
 - (一)就任校長時（民國 115 年 2 月 22 日）年齡未滿 65 歲（需於民國 51 年 2 月 23 日以後出生）
 - (二)應曾擔任專任教授 5 年以上及具有 4 年以上之教育行政或學術行政經驗，並符合《教育人員任用條例》第 10 條、《教育人員任用條例施行細則》第 13 條及本校校長遴選組織及運作辦法第 11 條之規定。
 - (三)具備下列各項條件：
 1. 公認之學術成就與聲望。
 2. 高尚之品德情操。
 3. 卓越之行政領導能力。
 4. 前瞻之大學教育理念。
 5. 有爭取及妥善運用資源之能力。
 - (四)本校校長候選人應超越政治、宗教、黨派等利益，以書面承諾於擔任校長期間，不得兼任任何政黨職務。
- 三、依《本校校長遴選組織及運作辦法》第12條規定，校長候選人依下列方式推薦之：
 - (一)中央研究院院士 3 人以上之連署，得推薦 1 人。
 - (二)國內外大學校院教授、副教授、助理教授、學術研究機構研究員、副研究員、助理研究員（助理研究員）10 人以上之連署，得推薦 1 人。
 - (三)本校校友 30 人以上之連署，得推薦 1 人。
 - (四)內政部核准成立之各學術專業團體，經各該團體正式議決，得推薦 1 人。
 - (五)本校學生會，經該會正式議決，得推薦 1 人。
- 四、推薦期間：即日起至114年8月25日下午5時止。

Extended Search for the 15th President of National Taiwan Normal University

1. National Taiwan Normal University (NTNU) is now publicly calling for nominations for the position of the 15th University President. The term of appointment shall commence on February 22, 2026, and conclude on February 21, 2030. Qualified individuals are encouraged to apply. The presidential term is four years, with the possibility of reappointment for one additional term in accordance with relevant regulations.
2. In accordance with Article 33 of the Act Governing the Appointment of Educators and Article 11 of the NTNU Directives for the Organization and Operation of the Presidential Selection Committee, the eligibility requirements and qualifications for candidates are as follows:
 - (1) The candidate must be under 65 years of age as of the date of appointment (i.e., born on or after February 23, 1962).
 - (2) The candidate must have at least five years of experience as a full-time professor and at least four years of experience in educational or academic administration. The candidate must also meet the requirements stipulated in Article 10 of the Act Governing the Appointment of Educators, Article 13 of the Enforcement Rules of Act Governing the Appointment of Educators, and Article 11 of the NTNU Directives for the Organization and Operation of the Presidential Selection Committee.
 - (3) The candidate must possess the following qualifications:
 - a. Recognized academic accomplishments and reputation
 - b. Exemplary moral character and integrity
 - c. Proven administrative and leadership abilities
 - d. A visionary philosophy for higher education
 - e. Competence in securing and effectively managing resources
 - (4) Candidates must demonstrate political, religious, and partisan neutrality. A written commitment must be provided, affirming that the candidate will not concurrently hold any position within a political party during the presidential term.
3. In accordance with Article 12 of the NTNU Directives for the Organization and Operation of the Presidential Selection Committee, presidential candidates may be nominated through one of the following methods:
 - (1) Joint nomination by three or more Academicians of Academia Sinica.
 - (2) Joint nomination by ten or more individuals holding the position of professor, associate professor, assistant professor, research fellow, associate research fellow, or assistant research fellow at universities or academic research institutions in Taiwan or abroad.
 - (3) Joint nomination by thirty or more alumni of National Taiwan Normal University.
 - (4) Nomination by academic or professional organizations officially approved by the Ministry of the Interior, following a formal resolution by the respective organization.

- (5) Nomination by the NTNU Student Association, following a formal resolution passed by the Association.
4. Submission Period for Nomination: Open until 5:00 p.m. on August 25, 2025.
